





That law forbids anyone convicted of a violent felony to own or possess a vest, unless the person wearing the vest is an employee who is doing so in order to perform a lawful business activity and who has obtained prior written certification from the employer. A violation incurs a maximum of three years in prison. And using a vest during the commission of a federal crime of violence or a federal drug-trafficking crime will result in an enhanced sentence. (42 U.S.C. Section 3796II-3(d)(1). A few states prohibit the use or possession in specified situations or circumstances, without regard to the criminal background of the wearer. One state prohibits wearing armor on school property or school-sponsored functions (Louisiana), while in Connecticut, sale of body armor must be done in person—Internet and phone purchases are illegal.
